

## Business Banking Account Opening Checklist

Thank you for your interest in opening a business banking account with APGFCU.

## Important Information About Procedures For Opening A New Account

To help the government fight the funding of terrorism and money laundering activities, federal law requires all financial institutions to obtain, verify, and record information identifying each person who opens an account.

## What This Means For You

When you open an account, we will ask for your name, address, date of birth (for individuals), and other information to help us to identify you. We may also ask to see your driver's license (for individuals) or other identifying documents<sup>1</sup>. In addition, you will be required to fill out paperwork for APGFCU. Below is a list of documents based on business type that will be needed in the account opening process. ## **Membership Eligibility**

Business must be located in Harford or Cecil County or portions of Middle River.
